Improving housing stability

Stable housing is the foundation for economic security and community well-being. ADVOCAP operates with the Housing First approach, providing essential support to individuals striving for long-term stability and working to establish access to safe, affordable homes. Through **Down Payment Assistance**, families take critical steps toward homeownership and breaking cycles of poverty. By providing deferred loans for down payments, this program makes homeownership a reality for those who otherwise could not afford it.

For those already in homes but facing financial hardship, our programs like

Foreclosure Prevention (ended in 2024) and Homeowner Rehabilitation offer critical assistance. Foreclosure Prevention helped homeowners navigate financial difficulties and avoid losing their homes. The Homeowner Rehabilitation program provides funds for necessary repairs, ensuring that families can live in safe and healthy environments. These efforts help stabilize neighborhoods and keep communities strong.

ADVOCAP **Affordable Housing** offers quality rental units in Fond du Lac, Green Lake, and Winnebago counties, giving families the stability needed to pursue education, employment, and self-sufficiency. By providing safe, well-maintained rental properties, we help ensure that individuals and families have a foundation on which they can build a more secure future.

In addition to providing stable housing, we work to make homes safer, more comfortable, and energy efficient. Weatherization, HE+ HVAC, and HE+ Water Conservation Programs work to lower energy costs and improve homes through assistance such as adding insulation, servicing furnaces, or repairing leaking pipes. ADVOCAP also manages Wisconsin's Home Energy Assistance Program (WHEAP) for Green Lake County, which offers financial assistance for heating and electric bills during the heating season.

Our programs to improve housing stability support families in allocating more resources toward education, healthcare, and other essential needs, helping to create long-term financial security.

Addressing homelessness

Following the Housing First approach,
ADVOCAP believes that individuals need
stable housing before addressing issues like
employment or substance use challenges.
By securing immediate necessities such as
shelter and food, people can focus on longterm stability. This approach restores dignity
and connects more people to opportunities
for healthy, more stable living environments.

Our **Homeless Assistance Programs** provide individuals and families experiencing homelessness with rental assistance and supportive services. ADVOCAP's holistic, individualized case management is a key pillar of our work in addressing homelessness. This includes housing search support, stability planning, referrals for job training, financial literacy, and mental health services.

Opportunity Center: Bringing services together

In late 2024, ADVOCAP saw a need for a safe, welcoming space for low-income individuals in Fond du Lac to get support navigating the system. Our **Opportunity Center** is the culmination of ADVOCAP's mission in action. We provide a daytime drop-in center where our diverse programs and expertise come together to provide comprehensive, wraparound support.

Temporary financial assistance through our **Community Response Programs** in Fond du Lac, Green Lake, and Winnebago Counties helps prevent evictions and utility shut-offs. Additional supports like clothing vouchers and employment aid — such as bus passes and work attire — ensure individuals can continue to work toward self-sufficiency.

ADVOCAP's financial assistance, case management, and wraparound services help stabilize households and support long-term housing success.

ADVOCAP helped me with getting my FoodShare and health insurance, and they helped me look for places to live... It's nice to have a sounding board where you can tell people what's going on and they point you in the right direction when possible. Increasing food security

Food security is the foundation of physical, mental, and emotional health. When individuals and families don't have to worry about being able to afford their next meal, stress levels decrease, leading to better mental well-being. Consistent access to healthy food also supports physical health, reducing the risk of chronic illnesses and promoting a better quality of life.

ADVOCAP's **Senior Nutrition Program** ensures that elderly and some disabled individuals in Winnebago County receive regular meals, reducing food insecurity and promoting health through nutrition.

Home-Delivered Meals provide healthy meals to homebound individuals, while Congregate Meals offer nutritious lunches in a cafeteriastyle setting, supporting seniors' independence, health, and social connectedness.

Our **Community Gardens** empower families to grow fresh produce, improving nutrition and reducing grocery expenses. Families not only gain access to fresh foods, but also develop valuable skills in gardening and self-sufficiency, reinforcing the importance of local food sustainability.

For families struggling with food security, **The Emergency Food Assistance Program** (**TEFAP**) supplies essential foods through local pantries and shelters, reducing financial strain and ensuring no one goes hungry. Families in need can access fresh and nonperishable food items, bridging the gap during difficult times.

The ADVOCAP **Head Start Program** also plays a vital role in supporting food security by providing nutritious snacks and meals to children while they're in the classroom. This ensures that young learners have consistent access to healthy food.

Building community connections

Reliable transportation is a key driver of independence and economic security. Our **Transportation Program** removes barriers by providing rides to critical appointments and essential services, ensuring that individuals are able to maintain their quality of life.

ADVOCAP's **Senior Friends Program** volunteers connect with elderly and disabled individuals through visits or phone calls to reduce social isolation and promote independence. Senior Friends help to build a more compassionate and engaged community.

Volunteers with our **Foster Grandparent Program** support school-age children by helping them with academics and offering caring mentorship that fosters success and confidence. When we invest in the next generation, our communities are forever growing stronger.

ADVOCAP's volunteer programs also have profoundly positive impacts on our volunteers themselves. By building meaningful connections and making a tangible difference in the lives of others, volunteers experience a deep sense of purpose, improved mental well-being, and a stronger sense of community.

Creating workforce opportunities

One pillar of a strong community is an employed workforce. ADVOCAP's **Business Development Program** helps low-income entrepreneurs launch and grow businesses, creating jobs and economic growth that benefit entire communities. By offering training, business plan development, and access to financial resources, this program empowers individuals to take control of their economic future and contribute to local prosperity.

Access to reliable transportation is another critical factor in employment success. Our Work N Wheels and Funds for Fines
Programs remove barriers by providing access to affordable, reliable vehicles and assisting individuals in regaining their driver's licenses. Without reliable transportation, many workers struggle to maintain employment. These programs help individuals reach job sites, attend trainings, and support their families through the confidence of a reliable ride to work.

Our Workforce Development Programs support both education and job training to help individuals build sustainable careers. The GED/HSED Program helps participants complete their foundational education. Our Skills Enhancement and Nursing Skills Programs provide financial assistance for training in fields like healthcare, childcare, and manufacturing. These programs not only transform individual lives, they help create pathways to stable jobs and uplift our communities.

ADVOCAP's **Opportunity Center**, a daytime drop-in center in Fond du Lac, works with low-income residents to overcome obstacles to entering the local workforce, among other services provided.

By removing barriers to employment through multiple programs and avenues, ADVOCAP is helping our neighbors achieve self-sufficiency and strengthen the local economy.

Supporting children & families

ADVOCAP's **Head Start Program** strengthens families and communities by offering high-quality early childhood education at no cost to eligible families. By fostering school readiness, social-emotional growth, and family engagement, we give children the foundation they need to succeed in school and beyond. Our program empowers parents as their child's first teacher, providing tools and resources to create a stable, nurturing home environment.

Through comprehensive services like health screenings, nutrition support, and access to community resources, we address whole-family needs. This ensures children flourish in and out of the classroom.

At ADVOCAP, our mission is to help people achieve self-sufficiency. Head Start embodies this commitment by breaking the cycle of poverty through education and family support.

When children receive a quality early education, they gain the skills necessary for lifelong learning, while their families gain access to opportunities that promote economic stability. Many parents in our program further their own education and are better supported in their careers with the opportunity to stay in the workforce while their child is in school.

The **Foster Grandparent Program** also creates opportunities to enhance child development by providing academic support and mentorship. Volunteers help children with reading, math, writing, and more. This intergenerational connection promotes learning, confidence, and emotional growth, helping children build skills essential for lifelong success. By investing in children and empowering families, ADVOCAP creates lasting change — building better futures and stronger, more resilient communities.

Head Start has helped my child's communication and socialization skills. He can tell me what he needs and what he wants.



Rosalie Tryon Barber Self-Sufficiency Award

This annual award honors ADVOCAP's first Executive Director, Rosalie Tryon Barber, who was appointed in 1965. Her leadership laid the foundation for ADVOCAP's mission to help individuals overcome poverty. The award recognizes individuals who, with ADVOCAP's support, have achieved economic stability and now give back by helping others do the same.

Mindi Multhauf

Mindi Multhauf was nominated for the **Rosalie Tryon Barber Self-Sufficiency Award** in recognition of her perseverance, resilience, and dedication to her family and community. As a participant of multiple ADVOCAP programs, her journey highlights a strong commitment to self-sufficiency despite significant challenges.

At 17, Mindi was expelled from high school for living independently as a minor, despite being on track to graduate early. Undeterred, she earned her High School Equivalency Diploma (HSED) through ADVOCAP. She later became a young mother of three, relying on ADVOCAP services for weatherization, job support, and Head Start education — including early intervention for her son Ethan's developmental challenges.

Financial stress, along with other stressors, led to the dissolution of her first marriage after the birth of her fourth child. Despite these challenges, Mindi persevered, stating she wanted to become self-sufficient and had a strong desire to break the cycle, as she didn't want her kids to struggle. Mindi met her nowhusband of ten years, Matt, who embraced her children as his own. The family moved to Hartford, where they are now homeowners. Mindi launched Sweet Ginger's Sugar Shop, an in-home bakery inspired by her son's nut allergy. At its peak, the business catered over 150 weddings and countless other events, and remains thriving today. She and Matt also founded Cheer Emotion, a pop-up store selling uplifting merchandise, which received positive feedback from the Wisconsin Association of Cheer and Pom Coaches.

Mindi's children, Ethan (19), Hannah (17), Kylie (15), and Leah (14), are all doing great and thriving. Ethan graduated high school with honors, defying early counseling predictions. Kylie recently achieved her long-held goal of joining the police cadet program and was named Rookie of the Year.


Mindi's family is also engaged in the community. Mindi founded and coached a cheer team when no local programs were available, ensuring everyone had a chance to participate. Today, around half of the high school cheerleaders went through her program. Additionally, the family has welcomed a foreign exchange student from Spain for the school year.

Though Mindi has long since transitioned from ADVOCAP's programs, the lasting impact is evident. Her resilience and dedication to her community make her highly deserving of this award.







Household




Employment



Looking ahead to 2025

As we look ahead to 2025, ADVOCAP remains committed to fostering positive change and creating opportunities for individuals and families across Fond du Lac, Green Lake, and Winnebago counties. We're excited about our projects on the horizon and the potential they have to make a lasting impact on the communities we support.

One of our new initiatives is the **Childcare Incubator** project in Oshkosh. This project will support low-income entrepreneurs and help meet the growing demand for affordable local childcare. By empowering individuals to establish sustainable childcare businesses, we aim to create jobs, provide valuable services, and ease the burden on working families in the region.

Another key focus for us is the **Opportunity Center** in Fond du Lac. Currently funded mainly through private donations, the Opportunity
Center plays a critical role in providing essential services and resources to individuals in need. In 2025, we will be seeking stable, long-term funding through partnerships with government and corporate entities, ensuring that the Center can continue to support participants and remain a vital community asset for years to come.

ADVOCAP recognizes the critical importance of **addressing mental health** needs among the individuals we assist. In 2025, we look to bring mental health support in-house by partnering with mental health professionals who will provide services directly from our offices. By eliminating transportation and scheduling barriers, we hope to make it easier for participants to access the help they need.

In 2025, ADVOCAP is exploring new ways to reduce social isolation among seniors, recognizing the importance of connection to overall well-being. We're looking at how increased access to technology might help seniors stay in touch with loved ones, friends, and volunteers through virtual communication. We are also considering how shared meals at local restaurants can offer a simple yet meaningful way to bring people together. These types of initiatives would open the door to more opportunities for connection, reduce loneliness, and help seniors feel more engaged and supported in their communities.

In 2025, we will undergo a **facilities assessment**, evaluating ADVOCAP properties and other potential development opportunities in our service area. We look forward to exploring solutions to the local affordable housing crisis and finding avenues for additional housing across the three counties in our service area.

Community Needs Assessment survey and report. ADVOCAP's Board of Directors and staff continually evaluate the needs of the communities we support to determine the best way to meet them. The Community Needs Assessment report is the result of data collected from community leaders, partners, and the low-income population we assist. It will guide our strategic priorities and program development in the years to come. This process ensures our efforts are data-driven, community-informed, and responsive to the evolving challenges facing our region.

As we step into a new year of community action, we remain committed to working together on creative, impactful solutions that help individuals and families build more stable, self-sufficient futures.
